ingredient highlights

- Eucalyptus Citriodora has a high citronella content, making it a fantastic natural insecticide. The scent is believed to confuse insects, making it difficult for them to find a host. In the likelihood of a bite, Eucalyptus Citriodora also doubles as an antiseptic.*
- Tea Tree Oil has been found to be an effective insect repellent. It has a very strong and distinctive smell while containing terpenes that repel insects. As it is anti-fungal and antiseptic, Tea Tree Oil can also be helpful if you are too late in applying as a natural repellent.*

suggested usage

- Lightly spray areas of exposed skin and spread evenly with hands. Do not spray directly onto the face; spray on hands and rub on face, being careful not to get too close to the eyes or in the mouth. Repeat as needed every 3-4 hours or if you notice a mosquito landing on your skin. Can also be sprayed into the environment to repel insects while outdoors.*
- For Pets: Spray lightly on hands and then apply to animal's coat. **Do not use on cats.** For fleas, please use goDésana's Essential Health For Animals Flea Repellent. For ticks, please use goDésana's Essential Health For Animals Tick Repellent.

- 3 to 5 years: 3 drops in 10 ml carrier oil
- 5 to 10 years: 6 drops in 10 ml carrier oil
- Pregnancy: Safe when used as directed starting in the 2nd trimester at 3% dilution (15 drops/1 ounce)

Bath

- Infant to 3 months: not recommended
- 3 months to 3 years: not recommended
- 3 to 5 years: not recommended
- 5 to 10 years: not recommended
- Pregnancy: not recommended
